- Must be working on/worked on a business or community project in Surrey or White Rock (including students) and/or;
- Must be working in the Surrey or White Rock business community and/or;
- Must be contributing/have recently contributed to a business or community related project in Surrey or White Rock and;
- Must be 25 years of age or younger prior to April 1, 2027
- Elected officials are not eligible to apply
- Previous winners of the award may not be nominated again for a three year period

This application must be signed and submitted with the questions on page 2 answered in a separate document.

All questions must be answered for your application to be considered by the judges.

### BUSINESS ACHIEVEMENT

1. Provide a brief description of the nominee's organization or business-related project (limit 250 words).
2. Provide a brief description of the nominee's professional achievements, ie: most recent accomplishments, past awards and/or distinctions (limit 200 words).

### LEADERSHIP AND COMMUNITY INVOLVEMENT

3. Describe the nominee's leadership abilities and experience (limit 200 words).
4. How is the nominee involved in the community? Are they a member of any community organizations, ie: committees, boards? Describe how this involvement has contributed to the success of the nominee or the growth of their company/project.

### SUMMARY

5. Describe the nominee's level of education (past, present and future) and/or any professional designations, certificates, diplomas, degrees or designations (limit 300 words).
6. Describe what makes the nominee unique/outstanding in their chosen field or within their business project (limit 100 words). This profile may be used in the awards ceremony and promotion.
